<u>TERT Initiative</u>: Kevin Haight shared a draft of the Idaho initiative documentation with committee members, the Attorney General and Idaho Office of Emergency Management for the development of an Idaho TERT (Telecommunicator Emergency Response Team). Erin Hidalgo has volunteered to be on the TERT Advisory Board.

**EMD:** Kevin Haight shared that the committee will begin working on mandating the use of EMD (Emergency Medical Dispatch) protocols in emergency communications centers (ECC) across Idaho. The state will not mandate which protocol an ECC will need to use. Kevin Haight stated that there are a number of states that already have a mandate in place currently.

<u>Life Saving Incident</u>: Carmen Boeger shared that a Nampa PD dispatcher handled an EMS call where a 15 year old called in to report a medical issue with his mother. Due to the dispatcher providing exceptional telephone CPR to the 15 year old son, who relayed the information to his father who performed CPR on his mother/wife, she survived. This occurred one year ago and on April 8, 2021 there will be a gathering so the family could meet the dispatcher who assisted in saving her life.
