#### **Update on GIS Project**

Ms. Pam Bond gave an update on the GIS project. Ms. Wilma Robertson has hired four GIS contractors to work with Idaho's PSAPs and collect local data.

#### **Committee Updates**

#### **PSAP** Committee

Mr. Lynn Parker reported that the PSAP Committee is working on their fall conference in Boise, which will be held October 02-04. PSAP quarter one training is currently in progress.

#### **Technology Committee**

Commissioner Taylor reported they received an update on the 700 MHz network at their last meeting. It's important to not forget about LMR, and it would be good to look into funding for radio projects. The committee also had an update from Mr. Brian Shields, the SWIC.

#### **Update on Dept of Commerce Broadband**

Mr. Ramon Hobdey-Sanchez the Broadband Project Coordinator with the Dept. of Commerce gave a presentation to the Commission on the funding sources that are being used to complete a broadband project that will connect the north and south parts of the state. There will be three different streams (?) of funding that will be available for broadband projects.

#### **DIGB** and Tribal Updates

<u>DIGB 1</u> – Commissioner Taylor reported that DIGB 1 is currently looking at bylaws and documentation on forming an active DIGB.

<u>DIGB 2</u> – Commissioner Taylor reported that DIGB 2 met January 12 and discussed how the broadband project can be leveraged for LMR between the counties. The DIGB is also looking forward to working with Benewah County on a grant project.

<u>DIGB 5</u> – Commissioner Guiberson introduced Mr. Adam McKinney, the DIGB 5 chair. Mr. McKinney reported that DIGB 5 is regionalizing 9-1-1 services around the Bannock County area.

<u>DIGB 6</u> – Commissioner Hulse reported that their last meeting was in January, and Mr. Brian Shields gave a SWIC update, and TICP update. Idaho State University has started attending DIGB 6 meetings. Their next meeting will be March 09.

<u>Tribal</u> – Commissioner Wheaton gave a report on Idaho's tribal communities working with counties to provide 9-1-1 services. Some communities will be applying for grants to participate in the broadband project.

Vice Chair Carreras reported that Chair Nancolas has asked that there be some training provided before the May 04 meeting, and for Commissioners to keep that in mind when booking their travel arrangements for that meeting.
