i. Clarifying remarks regarding 911 fee structures mentioned during Mar 7 meeting. Most states received Federal and State grants to off-set nonrecurring costs of NG911. Few states are able to pay for NG911 and refresh efforts with the fee alone. PM-Newman

b. New Business: 911 Fee information presented by PM:

- 1. NG911 is predominantly in State funding systems
 - a. 29 state collection/funding system (AZ/SD)
 - a. Generally cover Both-but decide on purchases
 - b. 20 hybrid (WA, CO)
 - a. State covers NG/GIS and local covers CHE
 - b. Some State covers ESInet

 - d. We are getting a bargain in Ms. Robertson and ITS being willing to take this on as an additional duty-not sure how long we have this luxury
 - 1. Commissioner Gonzalez
 - e. Of the 48 recommended actions; only four are being worked at this moment and they are all within the GIS Team.
 - 1. They have created standards
 - 2. Completed outreach and training of local units
 - a. Many Counties have no GIS capabilities
 - 3. Meeting NENA standards in layers-Location based routing
 - 4. Recent Problem in other states-Statewide consistency in PSAP layers
