# Introduction

FEMA GO is one electronic application solution that houses the grant management functions for all of FEMA's grant programs. This user manual addresses the Subapplication Development module for FEMA's hazard mitigation grant programs. In this module, a subapplicant user can create a new subapplication or continue working on a subapplication that was previously created.

The information requested in a subapplication includes general information about the subapplicant, including the Subrecipient Authorized Representative (SAR) who has the authority to sign and submit the subapplication to the applicant, and about the community(ties) that will benefit from the proposed mitigation activity. A user must also provide information about the approved hazard mitigation plan.

The user must describe the scope of work in detail to provide the applicant and FEMA with sufficient information to determine eligibility. Along with the tasks in the scope of work, the user will need to document the work schedule and estimate the costs to build a budget. Because federal agencies are required to only fund projects where the expected benefits will be greater than the expected costs, the user must provide information about the methodology and data used to determine cost-effectiveness, often from FEMA's BCA Tool. The user will provide information to assist FEMA in determining the EHP resources present within the project impact area, ensuring compliance with applicable EHP laws, and determining potential impacts to EHP resources. For subapplications being submitted under a nationally competitive grant program, the user will provide additional information about the community(ies), which helps FEMA rank subapplications in priority for award.

After all required fields have been completed and after a user commits to standard assurances and certifications, the subapplication can be submitted to a SAR for signature. Then the SAR will review the subapplication and submit it to the applicant.

This user manual is organized by sections that are associated with each main screen of a subapplication. In each section, an introduction is given to provide an overview of the purpose of the screen, and a list of information requirements is provided to help the user gather the information they will need to enter information completely and accurately on the screen. Along with the steps for completing each field or making each selection, job aids are provided as help to the user. Job aids include the names and links of references, sources, and resources for where a user can obtain information and data; tips that give the user helpful information on completing a step(s); and best practices that a user can follow to achieve the easiest and most streamlined process and to ensure the greatest accuracy and completeness. There are also some "help" boxes that explain the steps involved to gather accurate data or information from other systems that are necessary for completing fields in the FEMA GO system in an expedient manner.



# Attachments

At the bottom of most screens associated with a subapplication, the user will have the option to attach files. Attachments may be used to supply additional information about data entered on each screen, provide an explanation for a selection made, provide a justification for values entered, provide more detailed back-up documentation, etc. Follow these steps to manage attachments in the Attachments section of each screen.

## Steps

1. To attach a file:
  - a. Click the **Attach a Document** button.
  - b. In the pop-up window, navigate to the location where the file is saved.
  - c. Select the file, and then click Open.
  - d. After a file is added, the filename and attributes will be displayed:

### Attributes of attached files

- i. The **Filename** link will display in the Filename column.
- ii. The date that the file was uploaded will display in the Date uploaded column.
- iii. The FEMA GO login account for the person who uploaded the file will display in the Uploaded by column.

- iv. The size of the file will be displayed in the File size column.
  - v. In the **Description** column, the user can enter a description of the file.
2. To open and view an attached file, click on the **Filename** link in the Filename column.
3. To remove an attached file, click the **Delete** link associated with the file.



### Best Practice

There is a file size limitation of 1 gigabyte. For extremely large files, make every effort to reduce the file size when possible. This may entail actions such as attaching only select pages of a large document or supplying documentation in a more efficient file format.

# Hello, Welcome

From the first Hello, Welcome screen, an applicant user can start a new application, and a subapplicant user can either start a new subapplication or continue working on a subapplication that was already started. A user also can search for their organization, view the status of their organization's open grants, and view the status of the subapplications associated with their organization.

## Steps

There are four sections on this initial screen:

### 1. Apply for a new grant

- a. FEMA GO is one electronic application solution that will eventually include functionality for managing all of FEMA's grant programs. Search through the list of available FEMA grant programs to find the funding opportunity or to start an application or subapplication.
  - o An applicant user should find the specific funding opportunity, then select the **Start application** link to start a new application. For example, a funding opportunity may be FY 2020 Flood Mitigation Assistance Application.
  - o A subapplicant user should find the Mitigation: Hazard subapplication, then select the **Start subapplication** link to start a new subapplication.

### 2. My grants

- a. After one or more subapplications have been created, they will be listed here by name and type.
- b. To continue entering or revising information in a subapplication that has previously been started, select the **Continue subapplication** link.
- c. Due to limited space, if the list of subapplications is too long, they may not all be displayed in the My grants section. To view the status (i.e., the suborganization name, activity type, project title, and status) of each subapplication associated with the subapplicant's



Tip

The user can access the My grants window at any time by clicking on the FEMA GO icon in the upper left corner of any screen.



organization, either select the **View all grants** link at the bottom of the My grants section or select the **Grants** link in the top banner.

- d. For subapplications that have been created but not yet submitted for signature, the user may Select an action from the **I want to...** drop-down menu to either Continue subapplication development or View subapplication.



#### Select an action drop-down menu from My grants screen

- e. On the right side of the screen, the **Search, Show, Filters,** and **Sort** capabilities allow users to restrict or prioritize the applications and subapplications that appear on the screen.
  - o To use the **Search** capability, enter the Grant ID of the grant application.
  - o To use the **Show** capability, check the My grants box to show applications or check the My subapplication projects box to show subapplications
  - o To use the **Filters** capability, choose whether to filter the applications and subapplications by Grant program, Fiscal year, or Status. Then select the options from each dropdown menu.
  - o To use the **Sort** capability, sort by Fiscal Year or Grand Id, and then choose whether to display in Ascending or Descending order.

#### 3. Search for your organization POCs

- a. FEMA GO automatically adds the user's organization from SAM.gov.
- b. **Enter your DUNS number** in the field and then select the **Search** button to find out if your organization is in the system. Below the **Search** button, one of the following two search results will appear:
  - o If your organization was found in the system, the message "Organization is already registered" will be displayed, along with the name of the electronic business POC, or "eBiz POC." The name(s) of the eBiz POC will be displayed as it was entered in SAM.gov. The eBiz POC for your applicant organization is automatically assigned as the Authorized Organization Representative (AOR), and the eBiz POC for your subapplicant organization is the Subrecipient Authorized Representative (SAR).



Tip

The AOR or SAR eBiz POC must have a FEMA GO account because only these users can add more AOR or SAR accounts to their organization.

- o If your organization was not found in the system, the eBiz POC must register your organization on SAM.gov before any FEMA GO functionality will be enabled.

# Start a Subapplication – Mitigation: Hazards

After selecting the **Start subapplication** link from the Welcome screen, the user can create a new subapplication. When creating a new subapplication, some of the fields on this screen will be automatically populated based on the user's assigned roles and will not be able to be changed later. Some of the information selected or entered on this screen will be able to be changed later, after the subapplication is created, but other information will not be able to be changed later.

## Steps

Select or enter the following information:

### 1. **Organization you are applying for**

The organization(s) listed in the drop-down menu are based on the user's account credentials that were provided during account setup. Select the organization on whose behalf you are applying.

### 2. **Organization you are applying to**

The options in the drop-down menu are populated only after selecting the organization you are applying for and are based on the user's account credentials that were provided during account setup. Select the applicant organization to which the subapplication will be submitted.

### 3. **Subapplication title**

Create a title for the subapplication. Use enough identifying information so that the title can be found and distinguished easily from a list of many/multiple subapplication titles. (Note: The title can be changed later in the Scope of Work section of the subapplication.)



#### Best Practice

Title your subapplication using the subapplicant name, subapplication type, and year. For project subapplications, include the type of project and other identifying text, for example: City of Floodville Flood Elevation of 3 Homes - FY2020 BRIC.

#### 4. **Subapplication type**

- a. Select the type of subapplication from the drop-down menu:
  - Management cost—A separate subapplication for assistance to an applicant to manage its awarded subapplication(s). (This type is only available for an applicant and should not be confused with subapplicant management costs).
  - Plan—A subapplication to develop or update a hazard mitigation plan (per 44 CFR Part 201).
  - Project—A subapplication for any mitigation activity to reduce risk, including education and outreach.
  - Project scoping—A subapplication to assist with critical elements of developing other project subapplications, such as developing mitigation strategies, obtaining data, Environmental & Historic Preservation (EHP) compliance concerns, and other activities that may help to prioritize, select, and develop complete subapplications in a timely manner.
  - Technical assistance—A subapplication for an applicant to be able to provide technical assistance to subapplicants as they develop their subapplications. (This type is only available for applicants under the FMA program.)
- b. Note: The subapplication type cannot be changed after you select the **Start your subapplication** button at the bottom of the screen. So, if an incorrect subapplication type is selected, the user will need to start over to create a new subapplication.

#### 5. **Document control number (optional)**

If desired, supply a reference number for the subapplication that follows the subapplicant's internal document numbering and control method. Document control numbers can be used to track multiple subapplications.

#### 6. Select the button to **Start your subapplication**.

# Subapplicant Information

On this screen, the user will supply information about the type of submission and the Executive Order 12372 status for the subapplication. The user will define the type of subapplicant and state whether the subapplicant is delinquent on any federal debt.

## Steps

### 1. Type of submission

#### Type of submission

Select the type of submission from the drop-down menu:

- Pre-application—Select this option if the applicant to whom you will be submitting a subapplication has requested all potential subapplicants to submit an explanation of their intended subapplication. (After prioritizing the pre-applications, the applicant will request that complete subapplications be developed and submitted for those of highest priority.)
- Application—Select this option if you intend to develop and submit a full subapplication (i.e., for mitigation planning, mitigation project, project scoping, management costs, or technical assistance).
- Changed/Corrected application—Select this option if you have previously submitted a subapplication to an applicant and either you would like to revise that subapplication or the applicant has requested that you revise the subapplication.

## 2. Subapplicant Type

Select the type of subapplicant from the drop-down menu:

- State Government—Select this option if the subapplicant either is the same as the applicant or is a different state or territorial agency than the applicant.
- Local Government—Select this option if the subapplicant is a local unit of government, such as a city, town, village, or similar entity.
- Indian Tribal Government—Select this option if the subapplicant is either (a) a Federally recognized tribal government that is applying through a state government as the applicant or (b) a different tribal government agency than the applicant that is applying to a Federally recognized tribal government as the applicant. In the space provided, enter the tribal ID for the Indian tribal government.
- Special Governmental District—Select this option if the subapplicant is an independent, special purpose, governmental unit that exists as a separate entity with independence from general local governments.
- Private Non-Profit—Select this option if the subapplicant is a private non-profit organization and is applying to the applicant under the Hazard Mitigation Grant Program. In the fields displayed, enter text to describe the Legal status, Function, Facilities Owned, State Tax Id, and Federal Tax Id.
- Other—Select this option if the subapplicant is not one of the types of entities listed above. If this option is selected, provide a description of the type of subapplicant in the text box.

## 3. Is the subapplicant subject to review by Executive Order 12372 Process?

The Executive Order (E.O.) 12372, *Intergovernmental Review of Federal Programs* process refers to when applicant-level agencies conduct a review of subapplications for federal assistance. This process is often referred to as the “State Clearinghouse” or “Federal Assistance Clearinghouse.”

### Executive Order 12372 process

- If the state, territory, or tribe participates in the E.O. 12372 process:
  - a. Select Yes - This Pre-application/application was made available to the Executive Order 12372 Process for review on:

- b. In the text box displayed, enter the date, in MM/DD/YYYY format, that the subapplication was made available to the agency to initiate the E.O. 12372 process.
- o If the state, territory, or tribe does not participate in the E.O. 12372 process, select No, Program is not covered by E.O. 12372.
- o If the state, territory, or tribe participates in the E.O. 12372 process but this subapplication will not be reviewed in the E.O. 12372 process, select No, Program has not been selected by state for review.
- o If you do not know the answer to this question, check with the [State Hazard Mitigation Officer for your state or territory](#) to find out.

4. **Is the subapplicant delinquent on any Federal debt?**

- o If the subapplicant is not delinquent, then select No.
- o If the subapplicant is delinquent, then select Yes and provide an explanation of the debt delinquency status in the text box.
- o If you do not know the answer to this question, access the System for Award Management (SAM) to make the determination as described in the help box below.



Tip

Delinquent debt applies to the subapplicant organization and not to individual people who work on or sign the subapplication.



Tip

An explanation is required for any “Yes” response. Any undeclared federal debt will be discovered in the review and award process.

**Determining whether a subapplicant is delinquent on any Federal debt:**

1. Access the System for Award Management (SAM) System for Award Management at <https://www.sam.gov/SAM>.
2. Click Search Records in the top banner.
3. Conduct a search based on the entity name, DUNS Number, or one of the advanced search options to find the card for the entity.
  - o A green Entity box means that the entity is not subject to debt delinquency.
  - o If the answer to the question Has Active Exclusion? or Debt Subject to Offset? is Yes or if there is a purple Exclusion box, the entity is subject to debt delinquency.

4. If the entity cannot be found in the System for Award Management, the subapplicant must setup an account and then follow the steps above. Note: Be aware that the process of registering in SAM.gov may take up to 15 business days.



# Contact Information

The user will need to supply the contact information for at least one Subrecipient Authorized Representative (SAR) and at least one point of contact. The SAR is the person in the subapplicant's agency who has the authority to sign and submit the subapplication to the applicant. Note that in situations where the applicant is also acting as the subapplicant, the SAR may be the same person who submits the application to FEMA. A point of contact should be a person who is familiar with the subapplication and who could answer questions if/when contacted by the applicant.

#### Add a SAR

- a. Select the **Add a SAR** button.
- b. The options in the drop-down menu will be automatically populated with users in your organization. Select the person from your organization who will serve as a SAR. More than one SAR may be added by selecting the **Add a SAR** button and adding the information for as many people as desired.
- c. Once a name of a SAR is selected, system will automatically populate the SAR's contact information from their user registration information.
- d. A SAR can be removed by selecting the **Delete** link to the far right of the SAR contact.

### Add a point of contact

- a. Select the **Add a point of contact** button.
  - b. The options in the drop-down menu will be automatically populated with users in your organization. Select the person who will be a point of contact. More than one point of contact may be added by selecting the Add a point of contact button and adding the information for as many people as desired.
  - c. If the person you wish to name as the point of contact is not listed:
    - i. Select New contact from the drop-down menu.
    - ii. From the list of users, select the name for the point of contact. The system will automatically populate the person's contact information from their user registration information.
    - iii. Complete the information in the remaining fields (i.e., phone numbers and mailing addresses). Note that only fields labelled as "Optional" may be left blank. If required fields are left blank or if a number is entered in an incorrect format, the data entry box for that field will be highlighted in red and red text will explain the error.
  - d. If information for a previously selected point of contact needs to be updated, select the **Edit** link to the far right of the point of contact.
  - e. A point of contact can be removed by selecting the **Delete** link to the right of the point of contact.
  - f. Check if there are any fields where red text denotes errors and enter or correct the information as required.
3. Select the **Continue** button.

# Community

The user will supply important community identification and political information about the community(ies) that will benefit from the proposed mitigation activity.

To find and add communities that will benefit from the proposed mitigation activity, select the **Find communities** button.

- a. When the Find community section is displayed, the system automatically populates the name of the State based on the user’s account information.

### Find community

- b. To narrow the search, either search for a particular community by entering the name of the community in the Community name search box or search for all communities in a county by entering the name of the county in the County name search box.
- c. For statewide projects, do not enter anything in the Community name or County name search boxes.
- d. Select the **Search** button.
- e. The list of communities that match the search criteria will be displayed, along with corresponding information that comes from FEMA’s National Flood Insurance Program Community Information System (CIS) database: the Community name, County code, Community Identification (CID) number, status of Community Rating System (CRS) participation, CRS rating, and U.S. Congressional District.

- f. Check the box(es) for each community that will benefit from the mitigation activity. Check the **Select all** box to select all the communities in the list.
- g. For statewide projects, check the **Select all** box to select all the communities in the state or territory.
- h. Select the **Add Communities** button.

- i. After adding the community(ies), the U.S. Congressional District field will become editable. Because the U.S. Congressional District number that is automatically populated by the system may not be accurate, the system allows a user to manually correct it.



### Tip

The U.S. Congressional District number may not be accurate because Congressional Districts may change over time, and the CIS database may not be updated quickly enough. Also, a city or county may be situated in more than one Congressional district. The user can check to see if the Congressional District number(s) are accurate by visiting the [United States House of Representatives](https://www.house.gov/representatives/find-your-representative) website (<https://www.house.gov/representatives/find-your-representative>).

If desired, enter any clarifying text for the community or community information. For example, supply an explanation if the U.S. Congressional District number was changed.

    - a. If an attachment will supply additional information about the community(ies), use the **Attach a Document** button to attach a file.
    - b. To remove a file, select the **Delete** link.
  5. Select the **Continue** button.

# Mitigation Plan

Hazard mitigation plans are a principal component of FEMA's hazard mitigation programs. A FEMA-approved state or tribal hazard mitigation plan must be in place in order for any subapplicant in that state or tribe to be eligible for any mitigation funding. Additionally, a FEMA-approved local hazard mitigation plan must be in place in order for any local jurisdiction to be eligible for project funding. While supplying mitigation plan information is important for all subapplication types, additional steps are required to document that the approved mitigation plan contains information about a project for which a project subapplication is being developed. On this screen, the user will indicate whether there is a current, FEMA-approved mitigation plan and will provide key information about an approved plan.

For a mitigation project subapplication, the subapplicant should be aware that a FEMA-approved hazard mitigation plan must be in place by the application deadline.

Tribal governments are eligible to apply (a) directly to FEMA as an applicant or (b) through the state applicant as a subapplicant. The type of mitigation plan selected should be the type of plan that FEMA has approved.

iv. **Is this plan type standard or enhanced?**

This question will be displayed if the **Plan type** selected was either State Multi-Hazard Mitigation Plan or Tribal Multi-Hazard Mitigation Plan.

- If your state or tribe has an enhanced mitigation plan, select Enhanced.
- If your state or tribe does not have an enhanced mitigation plan, then select Standard.



Tip

To determine if your state or tribe has an enhanced mitigation plan, either contact your [State Hazard Mitigation Officer](#) or refer to FEMA's [Hazard Mitigation Plan Status website](#)

v. **Plan approval date**

FEMA approves mitigation plans by issuing a formal letter, which cites the official approval date. Enter that approval date in DD/MM/YYYY format. (Note that this date must be on or before the current date; it cannot be a date in the future.)



vi. **Proposed activity description (optional)**

In this optional field, provide any notes about the proposed activity.

vii. After supplying all of the plan details, select the **Save plan details** button.

viii. Selecting the **Cancel** link will remove all entered plan details.

ix. To update previously entered plan details, select the **Edit** link on the right side of the plan details box.

x. After entering the updated plan information, select the **Update plan details** button to save the updated information.



### Best Practice

Although the Proposed activity description is an optional field, users are strongly encouraged to include both the section number and page number of the mitigation plan where the activity is referenced. For easiest reference, scan the page(s) of the mitigation plan that references the proposed activity and include it in the **Attachments** section.

2. **Please provide any additional comments below (optional).**

- If No was selected because the subapplicant does not have an approved mitigation plan but still wishes to apply for mitigation funding, provide comments or an explanation. (For example, the subapplicant may have reason to believe that FEMA will approve their local hazard mitigation plan during the timeframe between the date the subapplication is submitted to FEMA and the application deadline.)
- If Yes was selected because the subapplicant has an approved mitigation plan, supplying additional comments is optional.

3. **Attachments**

- a. When developing a project subapplication, a subapplicant must demonstrate that the proposed project is addressed in the approved hazard mitigation plan. Rather than attach the entire mitigation plan, scan the page(s) of the plan that address the mitigation project to a file and then attach that file using the **Attach a document** button.
- b. To remove a file, use the **Delete** link.

4. Select the **Continue** button.

# Scope of Work

In the Scope of Work section, the user will provide detailed information about the proposed mitigation activity, including descriptions of the geographic location and how the proposed activities will be implemented. The type of information that will need to be supplied depends on the type of subapplication that was selected from the Start a subapplication screen (i.e., plan, project, project scoping, technical assistance, or management cost). Since a proposed project will often require construction, the greatest level of detail will need to be supplied for the scope of work for a project subapplication. The information requested to be provided in the Scope of Work section will provide the applicant and FEMA with sufficient information to evaluate the proposed activity for eligibility.

The information requirements and steps to complete the Scope of Work section for the different types of subapplications are provided in the following sections:

- Plan subapplication: Section A
- Project subapplication: Section B
- Project scoping subapplication: Section C
- Technical assistance subapplication: Section D
- Management cost subapplication: Section E

## A.Scope of Work for a Plan Subapplication

The scope of work for a plan subapplication can be for either developing a new or updating an existing hazard mitigation plan per 44 CFR Part 201 requirements.

### Steps

#### 1. Title of proposed activity

The title displayed for the proposed activity is the title that the user entered from the **Start a subapplication** screen. After a subapplication is created, its title can only be changed in this field, and changes made to the title here will be cascaded throughout the subapplication. The user may change the title here whenever needed.

#### 2. Primary activity type

- a. Select the **Primary activity type** from the drop-down menu that most closely fits the intended mitigation planning activity.
- b. In some cases, after a Primary activity type is selected, a list of sub-activities will be presented. Select the **Primary sub-activity type** from the drop-down menu that corresponds to the intent of the subapplication. If Other or Other plan is selected, supply an explanation of the sub-activity type in the window provided.
- c. After a Primary activity type is selected, a list of secondary activity types will be displayed. If applicable, select the **Secondary activity type** from the drop-down menu that corresponds to the intent of the subapplication.
- d. In some cases, when a Secondary activity type is selected, a list of secondary sub-activities menu may be displayed. In this case, select the **Secondary sub-activity type** from the drop-

down menu that corresponds to the intent of the subapplication. If Other or Other plan is selected, supply an explanation of the sub-activity type in the window provided.

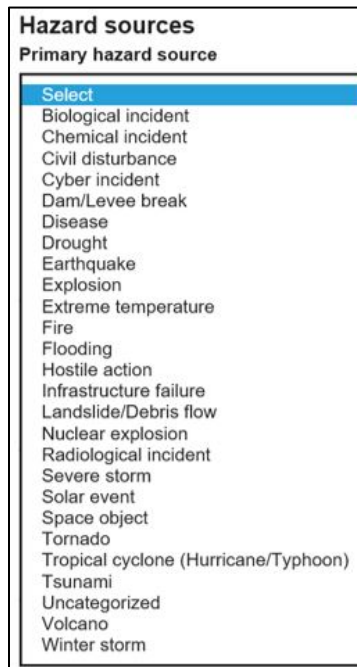
- e. If a Secondary activity type is selected, a list of tertiary activity types will be displayed. If applicable, select the **Tertiary activity type** from the drop-down menu that corresponds to the intent of the subapplication.
- f. In some cases, when a Tertiary activity type is selected, a list of tertiary sub-activity types may be displayed. In such a case, select the **Tertiary sub-activity type** from the drop-down menu that corresponds to the intent of the subapplication. If Other or Other plan is selected, supply an explanation of the sub-activity type in the window provided.

### 3. Geographic areas description

Supply a general description of the area that will be covered by the proposed plan, including the communities and counties that are expected to participate in the planning process. The description may include prominent hazard-creating features like rivers, coastlines, and faults.

### 4. Hazard sources

- a. The hazard source refers to the hazard risk that will be analyzed in the mitigation plan. Select the **Primary hazard source** from the drop-down menu that would be the most significant hazard risk that will be analyzed in the mitigation plan.

- b. After a Primary hazard source is selected, the user has the option to select a **Secondary hazard source**. After a Secondary hazard source has been selected, it can be removed by selecting the Select option at the top of the drop-down menu.
- c. After a Secondary hazard source is selected, the user has the option to select a **Tertiary hazard source**. After a Tertiary hazard source has been selected, it can be removed by selecting the Select option at the top of the drop-down menu.

**Tip**

The system allows a user to indicate a maximum of three hazard sources. If more than three hazard sources are applicable, indicate the three hazards (analyzed in the mitigation plan) that are the most prevalent. Then indicate the other hazard sources by supplying an **Additional comment** or by providing an **Attachment**.

## 5. Evaluation process description

For plan update activities, explain the process that the subapplicant will follow to review and evaluate the existing hazard mitigation plan to be updated.

## 6. Implementation process description

Explain the general process that the subapplicant will follow for completing the mitigation planning work, making references to FEMA's [mitigation planning requirements](https://www.fema.gov/emergency-managers/risk/hazard-mitigation-planning) (<https://www.fema.gov/emergency-managers/risk/hazard-mitigation-planning>).

## 7. Primary sources description

List the sources of information that will be used during the mitigation planning process, such as previously completed mitigation plans and new or updated risk data sources.

## 8. Staff and resources description

Describe the staff—whether existing or hired—that the subapplicant will use in the planning process. Name the resources—which refers to equipment and supplies—that will be made available by the subapplicant.

## 9. Additional comments (optional)

If desired or if it would be helpful for reviewers, add narrative scope of work comments.

## 10. Attachments

- a. Use the **Attach a Document** button to attach each piece of documentation that supports answers provided in the Scope of work screen.
- b. To remove a file, click the **Delete** link.

11. Select the **Continue** button.

## B. Scope of Work for a Project Subapplication

A project subapplication will be created for any mitigation activity taken to reduce risk. The [Hazard Mitigation Assistance Guidance](https://www.fema.gov/grants/mitigation/hazard-mitigation-assistance-guidance-and-addendum-fy15) (https://www.fema.gov/grants/mitigation/hazard-mitigation-assistance-guidance-and-addendum-fy15) provides a list of eligible mitigation projects. In the Scope of Work section, the user will classify the proposed mitigation project as either construction or non-construction. While construction projects make physical changes to the landscape or to buildings to change their risk parameters, non-construction projects are for mitigation activities like education and outreach programs that do not make physical changes to the natural or developed landscape.

The title displayed is the title that the user entered from the **Start a subapplication** screen. After a subapplication is created, its title can only be changed in this field, and changes made to the title here will be cascaded throughout the subapplication. The user may change the title here whenever needed.

#### 2. Primary activity type

- a. From the drop-down list, select the **Primary activity type** that most closely fits the intended mitigation project. For assistance with identifying a primary activity type, consult the Eligible Activities section of the most recent [Hazard Mitigation Assistance Guidance](https://www.fema.gov/grants/mitigation/hazard-mitigation-assistance-guidance-and-addendum-fy15) (https://www.fema.gov/grants/mitigation/hazard-mitigation-assistance-guidance-and-addendum-fy15)

#### Primary activity types

- b. In some cases, when a Primary activity type is selected, a list of sub-activity types will be displayed. For example, if Retrofit is selected as the Primary activity type, a Primary sub-activity type menu will be displayed for the user to clarify what hazard type will be mitigated by the Retrofit (i.e., seismic, wildfire, wind, or other). Select the most appropriate **Primary sub-activity type** from the drop-down menu. If Other is selected, supply an explanation of the sub-activity type in the window provided.
- c. After a Primary activity type is selected, a list of secondary activities types will be displayed. In cases that include more than one eligible mitigation activity, a **Secondary activity type** should be selected. For example, both acquisition and elevation may be components of a flood mitigation project or a generator may be part of a wind retrofit project. If Other is selected, supply an explanation of the activity type in the window provided. If there is no secondary activity type for the project, this field can be left blank.
- d. In some cases, when a Secondary activity type is selected, a list of secondary sub-activity types will be displayed. For example, in a case where a generator is part of a wind retrofit project, a secondary sub-activity type for a generator would be displayed for the user to clarify whether the generator is permanent or portable or if the sub-activity is for generator hookups. Select the **Secondary sub-activity type**. If Other is selected, supply an explanation of the sub-activity type in the window provided.

- e. If a Secondary activity type is selected, a list of tertiary activity types will be displayed. Select the most appropriate **Tertiary activity type**. If Other is selected, supply an explanation of the activity type in the window provided. If there is no tertiary activity type for the project, this field can be left blank.
- f. In some cases, when a Tertiary activity type is selected, a list of tertiary sub-activity types will be displayed. Select the **Tertiary sub-activity type**. If Other is selected, supply an explanation of the sub-activity type in the window provided.

### 3. Geographic areas description

Supply geographic information that is as detailed as possible about the project being scoped. The description of the geographic areas will depend on the project type. For example, the geographic area for a wildfire hazardous fuels reduction project would be described as an area mitigated; the geographic area for a utility mitigation project would be described in terms of linear features; and a project for culvert improvements would be described as points on a map.

 **Tip**

Note that other geographic information such as geospatial coordinates (i.e., latitude and longitude) will be entered in the **Location** section of the subapplication.

### 4. Community lifelines

- a. [Community Lifelines](https://www.fema.gov/emergency-managers/practitioners/lifelines) (https://www.fema.gov/emergency-managers/practitioners/lifelines) are the most fundamental services in the community that, when stabilized, enable all other aspects of society to function. Therefore, mitigating the loss of lifelines improves a community’s resilience. From the drop-down menu, select a **Primary community lifeline** to name at least one community lifeline applicable to the proposed project.

- b. After a Primary community lifeline is selected, a list of primary sub-community lifelines will be enabled. The sub-menu displayed will be different for each primary community lifeline selected. Select a **Primary sub-community lifeline**.

- c. The user has the option to select a **Secondary community lifeline**. Making a selection is optional and will depend on the nature of each individual project being scoped and whether another lifeline is applicable. After a Secondary community lifeline has been selected, it can be removed by selecting the Select option at the top of the drop-down list.
- d. After a Secondary community lifeline is selected, a list of secondary sub-community lifelines will be displayed. Select a **Secondary sub-community lifeline**.
- e. After a Secondary community lifeline is selected, the user has the option to select a **Tertiary community lifeline**. Making a selection is optional and will depend on the nature of each individual project being scoped and whether another lifeline is applicable. After a Tertiary community lifeline has been selected, it can be removed by selecting the Select option at the top of the drop-down list.
- f. After a Tertiary community lifeline is selected, a list of tertiary sub-community lifelines will be displayed. Select a **Tertiary sub-community lifeline**.

## 5. Hazard sources

- a. The hazard source refers to the hazard type that will be mitigated by the project being scoped. Select a **Primary hazard source** from the drop-down menu. If Uncategorized is selected, supply an explanation in the window provided.

#### Primary hazard sources

- b. After a Primary hazard source is selected, the user has the option to select a **Secondary hazard source**. Making this selection is optional and will depend on the nature of each individual project and whether another hazard source is applicable. For example, a coastal elevation project could have a secondary hazard because it could mitigate both a flooding hazard and a hurricane wind hazard. After a Secondary hazard source has been selected, it can be removed by selecting the Select option at the top of the drop-down list.
- c. After a Secondary hazard source is selected, the user has the option to select a **Tertiary hazard source**. Once a Tertiary hazard source has been selected, it can be removed by selecting the Select option at the top of the drop-down list.

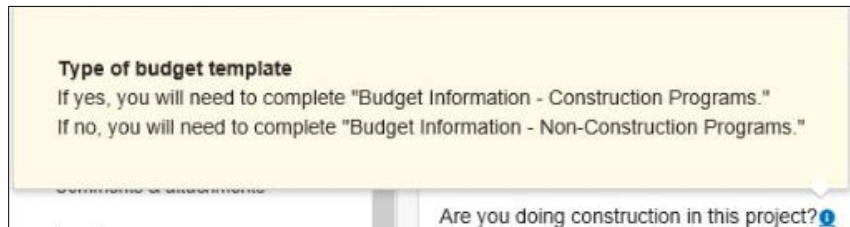
#### 6. Is this a phased project?

- a. Select Yes or No. For assistance, consult with your State Hazard Mitigation Officer or the latest Hazard Mitigation Assistance Guidance for the definition and procedural information for phased projects at <https://www.fema.gov/grants/mitigation/hazard-mitigation-assistance-guidance-and-addendum-fy15>.
- b. For phased projects, the system will require users to enter Phase 1 and Phase 2 cost estimate information in the Budget screen.

#### 7. Are you doing construction in this project?

- a. Select Yes or No. For most project types, the answer will be Yes; however, education and outreach projects are examples of projects that would not involve construction.

- b. After answering this question, the system will automatically select the applicable budget forms and assurances (i.e., either for construction or non-construction) for future screens, and a message will be displayed to inform the user.



### Budget template information message

- c. Note that the answer to this question will determine what information will be requested in the **Budget** section of the subapplication, and any data entered in the Budget section of the subapplication will be lost if the answer to this question is changed here.

## 8. Population affected

Supply the percentage of the population that will be affected by the proposed project.

## 9. Detail/description of stated percentage

Explain how the percentage provided in the previous field was determined. There is no official guidance about how the population affected should be determined. However, the number of people who will benefit from the proposed project should be a known variable from the scope of work. Then divide this number by a total population to determine the percentage of the population affected.

## 10. Provide a clear and detailed description of your proposed activity

Describe the need for the proposed project, including citing past event and damage history. Explain how the proposed project will mitigate such damages and losses in the future.



### Best Practice

A complete Scope of Work should answer any potential questions that a person who is completely unfamiliar with the problem might have such as: Who? What? Where? When? Why?

## 11. How will the mitigation activity be implemented?

Explain the process that the subapplicant will follow to implement the mitigation project. Include information about the procurement process that the subapplicant will follow, if that process will be required.

**12. Describe how the project is technically feasible and will be effective in reducing the risk by reducing or eliminating damage to property and/or loss of life in the project area.**

- a. Technical feasibility refers to the extent that the completed project will mitigate damages and losses as claimed in the subapplication. Demonstrating technical feasibility often requires providing technical documentation, which requires consultation with design professionals like Professional Engineers or licensed architects.
- Engineering design documentation demonstrates how the proposed project will reduce risk after it is completed. Documentation may include preliminary schematic or engineering drawings, a clear explanation of design parameters that will be followed, and the level of protection. Examples of the level of protection are protection to a certain windspeed for hurricane wind retrofits or protection to a certain flood recurrence interval (e.g., a 100-year or 1%-annual chance flood). Any engineering practices and best practices proposed in the design should be explained.
  - For certain hazard types, FEMA has developed design standards that must be followed in order for a project to be considered eligible for funding. For example, FEMA Publication 361 prescribes design standards for safe room projects.
  - For projects that require professional input, a response to this prompt may be provided by them or may be taken from technical reports such as a project feasibility study.
  - Technical feasibility should also explain any required building or construction codes, such as the International Wildland Urban Interface Code for some areas that are at high risk for wildfires.
- b. Technical documentation should be attached in the **Attachments** section at the bottom of the screen.

**13. Who will manage and complete the mitigation activity?**

Explain how the project will be managed. For example, will a local community provide staff as a project manager to oversee the progress? Explain whether existing or hired staff will be used. Name resources, which refers to equipment and supplies.

**14. Will the project address the hazards identified and what risks will remain from all hazards after project implementation (residual risk)?**

Residual risk refers to the amount of risk that will *not* be mitigated by the proposed project. For example, if a culvert that is washed out by a 10-year (10%-annual chance) flood would be replaced by a culvert that provides 100-year (1%-annual chance) capacity, the residual risk would be any event greater than the designed 100-year level of protection. The response to this question often can use the same source of information that was used for the response for the technical feasibility prompt above.

### 15. When will the mitigation activity take place?

Provide a general narrative description that starts with the application deadline and assumes several months for FEMA's review and awarding process. Note that the user will provide a detailed project schedule in the **Schedule** section of the subapplication.

### 16. Explain why this project is the best alternative. What alternatives were considered to address the risk and why was the proposed activity considered the best alternative?

Identify and provide a description of other projects that could mitigate the problem/risk and explain why those were not selected. This ensures that the project subapplication is the result of a locally driven, deliberative process.



Tip

The approved hazard mitigation plan can be a reliable source of information about other projects that were considered to address the risk.

### 17. Please identify the entity that will perform any long-term maintenance and provide a maintenance schedule and cost information.

Long-term maintenance helps to ensure that a mitigation project will maintain its effectiveness at reducing risk beyond its initial construction, into the future.

- To ensure long-term maintenance will be provided, certain project types require operations and maintenance plans.
- Name the entity that will be performing the long-term maintenance.
- Supply a schedule of how often maintenance will be conducted.
- Information on maintenance costs is likely to be contained in documentation used in the benefit-cost analysis (in the **Cost-effectiveness** section of the subapplication).



Tip

If maintenance costs are applicable to the project, they must be included in the benefit-cost analysis; however, they cannot be included in the project's detailed budget.

### 18. Additional comments (optional)

19. If desired or if it would be helpful for reviewers, add narrative scope of work comments.

### 20. Attachments

- a. Use the **Attach a Document** button to attach each piece of documentation that supports answers provided in the Scope of work screen, including mitigation activities, community lifelines, hazard sources, and mitigation approach and effectiveness.
- b. To remove a file, click the **Delete** link.

21. Select the **Continue** button.

## C. Scope of Work for a Project Scoping Subapplication

The goal of a project scoping subapplication is to “scope out,” or make preparations, before developing a complete project subapplication. Most often, project scoping funds are awarded for complex projects that require an exceptional amount of development that is beyond a subapplicant’s resources to complete in support of a regular project subapplication. If the project scoping process determines that the project would likely meet all eligibility requirements, the expectation is that the subapplicant would seek project funding in the future.

#### 2. Primary activity type

- a. From the drop-down list, select the project scoping **Primary activity type** that most closely fits the intended mitigation project. For assistance with identifying an activity type, consult the *Eligible Activities* section of the most recent [Hazard Mitigation Assistance Guidance](https://www.fema.gov/grants/mitigation/hazard-mitigation-assistance-guidance-and-addendum-fy15) (<https://www.fema.gov/grants/mitigation/hazard-mitigation-assistance-guidance-and-addendum-fy15>) or contact your [State Hazard Mitigation Officer](https://www.fema.gov/grants/mitigation/state-contacts) (<https://www.fema.gov/grants/mitigation/state-contacts>). If Other is selected, supply an explanation of the activity type in the window provided.

- b. After a **Primary activity type** is selected, a list of secondary activity types will be displayed. Select a **Secondary activity type**. If Other is selected, provide an explanation of the activity type in the window provided. If there is no secondary activity type for the intended mitigation project, this field can be left blank.
- c. If a Secondary activity type is selected, a list of tertiary activity types will be displayed. Select a **Tertiary activity type**. If Other is selected, supply an explanation of the activity type in the window provided. If there is no tertiary activity type for the intended mitigation project, this field can be left blank.

**3. Geographic areas description**

Supply geographic information about the project being scoped that is as detailed as possible. The description of the geographic areas will depend on the project type. For example, the geographic area for a wildfire hazardous fuels reduction project would be described as an area mitigated; the geographic area for a utility mitigation project would be described in terms of linear features; and a project for generators would be described as points on a map.

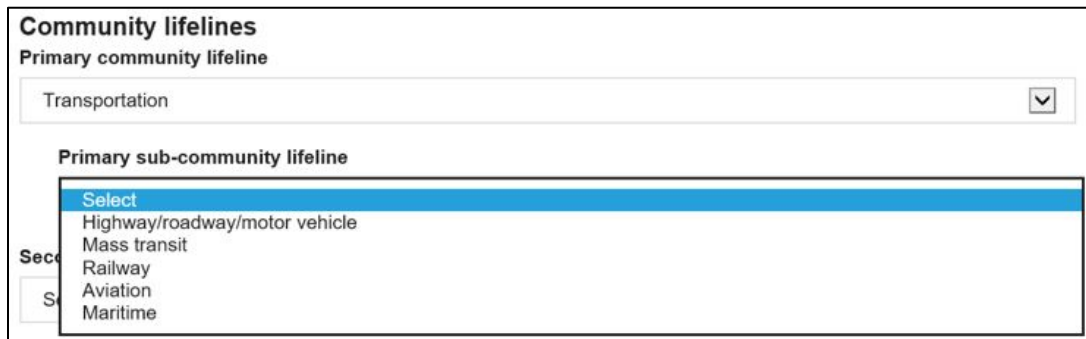
**4. Community lifelines**

- a. [Community Lifelines](https://www.fema.gov/emergency-managers/practitioners/lifelines) (https://www.fema.gov/emergency-managers/practitioners/lifelines) are the most fundamental services in the community that, when stabilized, enable all other aspects of society to function. Therefore, mitigating the loss of lifelines improves a community’s resilience. Select a **Primary community lifeline** to name at least one community lifeline applicable to the proposed project.

## 5. Hazard sources

- a. The hazard source refers to the hazard type that will be mitigated by the project being scoped. Select a **Primary hazard source** from the drop-down menu. If Uncategorized is selected, supply an explanation in the window provided.

#### Primary hazard sources

- b. After a Primary hazard source is selected, the user has the option to select a **Secondary hazard source**. Making this selection is optional and will depend on the nature of each individual project and whether another hazard source is applicable. For example, a coastal elevation project could have a secondary hazard because it could mitigate both a flooding hazard and a hurricane wind hazard. After a Secondary hazard source has been selected, it can be removed by selecting the Select option at the top of the drop-down list.
- c. After a Secondary hazard source is selected, the user has the option to select a **Tertiary hazard source**. After a Tertiary hazard source has been selected, it can be removed by selecting the Select option at the top of the drop-down list.

#### 6. How will the mitigation activity be implemented?

Explain the project scoping process that the subapplicant will follow.

#### 7. What is the scope of work of the proposal? Will it result in a complete project subapplication for future funding opportunities?

Provide as much information as possible that explains the need for the project, including the location, why the project is needed, the mitigation solution being scoped, and who will be doing the project scoping. The scope of work should state whether the project scoping effort will result in a complete project subapplication.

#### 8. Who will manage and complete the mitigation activity?

Explain how the project scoping process will be managed. For example, will a local community supply staff as a project manager to oversee the progress? Explain whether existing or hired staff will be used. Name resources, which refers to equipment and supplies.

**9. What are you doing to consider other risks in the project area?**

Describe risks from the same hazard being mitigated or from other hazards that will need to be addressed during the project scoping process.

**10. Is there an estimate for when the mitigation activity will take place?**

Supply a general explanation of when the project scoping activity could begin and when it could be completed. This estimate should be consistent with information provided in the **Schedule** section.

**11. What alternatives will be considered?**

Name and provide a description of other projects that could mitigate the problem and explain why those were not selected for project scoping.

**12. Do activities being considered align with hazard mitigation plan?**

Explain how the scoping for this project conforms with the FEMA-approved local or tribal hazard mitigation plan.

**13. Additional comments (optional)**

If desired or if it would be helpful for reviewers, supply other narrative comments about the project scoping scope of work.

**14. Attachments**

- a. Use the **Attach a Document** button to attach each piece of documentation that supports answers provided in the Scope of work screen, including mitigation activities, community lifelines, hazard sources, and mitigation approach and effectiveness.
- b. To remove a file, click the **Delete** link.

**15. Select the **Continue** button.**

## D. Scope of Work for a Technical Assistance Subapplication

Funding for technical assistance may be requested under the Flood Mitigation Assistance (FMA) program only. Funding for technical assistance is only available for an applicant—not a subapplicant. Technical assistance refers to assistance that an applicant provides to subapplicants as they develop their subapplications.

### Steps

#### 1. Title of proposed activity

The title displayed is the title that the user entered from the **Start a subapplication** screen. After a subapplication is created, its title can only be changed in this field, and changes made to the title here will be cascaded throughout the subapplication. The user may change the title here whenever needed.

#### 2. Primary activity type

Select Technical Assistance from the drop-down menu.

#### 3. Geographic areas description

Most often, an applicant will be using technical assistance funds to support FMA program activities statewide. Therefore, the user may enter the general description of “Statewide” in this field. However, if more detailed information is known at the time of application, then a more detailed description should be provided.

#### 4. What will the technical assistance funding be used for?

Explain how the technical assistance funds will be used by the applicant, especially highlighting how technical assistance activities will be kept separate from any management cost award activities. Consult the [Hazard Mitigation Assistance Guidance](https://www.fema.gov/grants/mitigation/hazard-mitigation-assistance-guidance-and-addendum-fy15) (<https://www.fema.gov/grants/mitigation/hazard-mitigation-assistance-guidance-and-addendum-fy15>) for a list of eligible technical assistance activities.

#### 5. **Primary sources description**

List the sources of information that will be used when implementing the technical assistance award, such as recent flood claim data and past FMA program outreach projects.

#### 6. **Staff and resources description**

Name the staff, whether existing or hired, that the applicant will use during the implementation of the technical assistance award. Name the resources—which refers to equipment and supplies—that will be made available by the applicant.

#### 7. **Additional comments (optional)**

If desired or if helpful to reviewers, add narrative comments about anything related to the scope of work.

#### 8. **Attachments**

- a. Use the **Attach a Document** button to attach each piece of documentation that supports answers provided in the Scope of work screen.
- b. To remove a file, click the **Delete** link.

#### 9. Select the **Continue** button.

## E. Scope of Work for a Management Cost Subapplication

Management costs are costs incurred by an applicant to manage its awarded subapplication(s). Management cost funding is only available for an applicant—not a subapplicant.

### Steps

#### 1. Title of proposed activity

The title displayed is the title that the user entered from the **Start a subapplication** screen. After a subapplication is created, its title can only be changed in this field, and changes made to the title here will be cascaded throughout the subapplication. The user may change the title here whenever needed.

#### 2. Primary activity type

Select Management Costs from the drop-down menu.

#### 3. Geographic areas description

Most often, an applicant will be using management costs to support mitigation activities statewide. At the time of application, an applicant has no way of knowing which subapplications will be awarded in a competitive review process. Therefore, the user may enter the general description of “Statewide” in this field. However, if more detailed information is known at the time of application, then a more detailed description should be provided.

#### 4. How will management costs support mitigation activities?

Explain how the applicant will use the management costs funds. Remember to explain if and how the applicant (as the recipient) will pass through management cost funding to the subrecipient(s).

5. **What staff and resources will be used to implement the activities (direct and indirect costs)?**

Explain whether existing or hired staff will be used. Name resources, which refers to equipment and supplies. “Direct costs” refers to expenses that can be applied directly for a specific award or subaward, while “indirect costs” refer to resources needed to manage the entire program, including multiple awards and subawards. Indirect costs might be used for cost items like office rent and utility costs. (More specific details for direct and indirect costs will need to be entered in the Budget section of the subapplication.)

6. **What activities will be funded?**

Explain the activities that the applicant expects to undertake in support of the subapplications to be submitted in its application.

7. **Additional comments (optional)**

If desired or if helpful for reviewers, add narrative comments about anything related to the scope of work.

8. **Attachments**

- a. Use the **Attach a Document** button to attach each piece of documentation that supports answers provided in the Scope of work screen.
- b. To remove a file, click the **Delete** link.

9. **Select** the **Continue** button.

# Schedule

In the Schedule section, the user will document the work schedule for the proposed mitigation activity by defining tasks and their proposed durations. Especially for project subapplications, it is common for an outside professional to prepare a detailed project schedule for the subapplicant. The user will need to enter the milestones from a prepared schedule into the system to create a consistent schedule format. The user will also supply an estimate of the start date, end date, and total duration of the entire mitigation activity.

- a. Enter the **Task name**, consistent with the schedule developed for the mitigation activity.
- b. Enter the **Task description**, which should be consistent with the work described in the Scope of work section of the subapplication.
- c. Enter the estimated **Start month** of the task using the number of the month within the total estimated months in the period of performance. For example, if a total period of performance of a mitigation activity is 30 months, a task may start in month 6.
- d. Enter the **Task duration** (in number of months).
- e. Select the **Save task** button to save all the information for that task.
- f. Repeat the above steps until all tasks that make up the work schedule are added.

 **Tip**


Make sure to include the often-overlooked tasks for signing award agreements, bidding, permitting, and closeout.

 **Tip**

The subapplicant should be familiar with the requirements of the project type to understand the schedule and whether the duration for each task is reasonable (see the FEMA HMA Guidance Addendum for the most common project types).

**3. Estimate the total duration of your proposed activities (in months).**

Enter the total duration of the proposed mitigation activity—or period of performance—in months.

 **Best Practice**

As a best practice, the total duration of the proposed mitigation activity should be 36 months or less.

#### 4. **Proposed project start and end dates**

- a. Enter the **Start Date** in MM/DD/YYYY format. To estimate the Start Date, predict the time that FEMA will need to review and award subapplications and applications.
- b. Enter the **End Date** in MM/DD/YYYY format. This should be equal to the **Start Date** plus the **total duration of your proposed activities**, i.e., the total number of days in the proposed period of performance.

5. Select the **Continue** button.



#### Tip

A reasonable estimate for FEMA's review time would be several months after the submission deadline. FEMA may require that an updated schedule be submitted upon award.



#### Tip

The schedule supplied in the subapplication is a proposed schedule. After award, a subrecipient will be able to request extensions for extenuating circumstances, such as construction delays.

# Budget

Similar to the process used in the Schedule section, in the Budget section, the user will build a budget (i.e., cost estimate) by adding cost items, which will eventually comprise the total cost for the mitigation activity. The data required to be provided in the budget forms depend on whether the mitigation activity involves construction. For project scoping, planning, management cost, and technical assistance subapplications, the system will display form fields applicable for non-construction mitigation activities. For project subapplications, the form fields displayed by the system will have minor differences, depending on whether the user showed (in the Scope of Work section) that a project will involve or will not involve construction. The system will automatically incorporate user-provided data into the applicable budget form.

## Steps

### 1. Add budget cost types and item(s)

- a. The heading of this section will depend on the type of subapplication:
  - o If the subapplication is for planning, management cost, or technical assistance, the following heading will be Budget type: Non construction.
  - o If the subapplication is for a project, the heading will depend on what was selected in response to the question “Are you doing construction in this project?” from the Scope of work screen.
    - If the response was No, then the heading will be Budget type: Non construction.
    - If the response was Yes, the heading will be Budget type: Construction.
- b. To begin documenting the budget, select the **+ Add cost type button**.

### 2. Add a cost type

- a. A cost type is a general category for costs that can be used to build the total project cost. From the Select cost type drop-down menu, select the only option available, Cost estimate.



#### Add a cost type

- b. Select the **Add this cost type** button.
- c. The Cost estimate section will be displayed. Note that as the user adds estimated costs into the system, the system will continue to calculate and update the **Grand total \$** amount.
- d. To begin documenting the budget line items for the Cost type: Cost Estimate section, select the **+ Add an item button**.



#### Tip

The total project cost should be consistent throughout the subapplication and its supporting documentation.

3. **Add an item**

- a. A cost item is an identifiable cost for a specific element of the mitigation activity. The cumulative cost items will add up to the total cost for the mitigation activity. Remember that the cost items in the budget should be closely aligned with the tasks outlined in the scope of work and schedule.

**Tip**

The size of the Cost type and Cost item sections can be controlled by clicking the triangle to the left of their titles.

- b. Enter the **Name of cost item**, using the same name as in the professionally developed budget/cost estimate. If the cost item relates directly to an element in the scope of work or to a task in the schedule, try to use the same name—or a similar name.
- c. Enter the **Quantity** of the cost item.
- d. Select the most applicable **Unit of measure** for the cost item from the drop-down menu.

**Tip**

The budget supplied with a subapplication reflects estimated costs. Exact costs will not be known until they are refined through the bidding and procurement process. If the subapplication is awarded, an accurate budget will minimize future budget constraints in case of cost overruns. Be aware that there may be limited potential for subapplicants to receive additional funds beyond the initially awarded amount.



### Units of measure

- e. Enter the **Unit price** of the cost item, i.e., the price of a single cost item.
- f. The system will automatically calculate the **Unit total** for the cost item by multiplying the **Quantity** by the **Unit price**.

- g. The next field displayed will depend on whether the mitigation activity was identified as a non-construction or a construction activity:

- o If the activity is a Non-construction mitigation activity, budget classes are applicable. A budget class is a way to assign and group general types of costs.



Subapplicants may wish to review the cost requirements provided in [2 CFR Part 200](https://www.ecfr.gov/cgi-bin/text-idx?tpl=/ecfrbrowse/Title02/2cfr200_main_02.tpl) ([https://www.ecfr.gov/cgi-bin/text-idx?tpl=/ecfrbrowse/Title02/2cfr200\\_main\\_02.tpl](https://www.ecfr.gov/cgi-bin/text-idx?tpl=/ecfrbrowse/Title02/2cfr200_main_02.tpl)), Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards.

- i. From the drop-down menu, **Select a budget class**. For example, if a contractor will be hired for the development of a mitigation plan, all cost items related to the plan development should be assigned to the “Contractual” budget class.

- o If the activity is a Construction mitigation activity, cost categories are applicable. A cost category is a way to assign and group types of costs for mitigation projects.
  - i. From the drop-down menu, **Select a cost category**. For example, all cost items related to the construction part of a mitigation project should be assigned to the “Construction” cost category.

- ii. Note that if the Contingencies or Miscellaneous cost category is selected, you will need to supply an explanation in a budget narrative.

- h. If the cost item is expected to be expended before the subaward is issued, then check the **Pre-award** box. Pre-award costs are those that are spent after the application period opens, but before receiving an award. For example, a subapplicant may wish to identify pre-award costs for time spent developing a project benefit-cost analysis or other subapplication development tasks.
  - i. For a phased project, select responses from the **Project phase** drop-down menu:
    - o Select the phase (i.e., Phase 1 or Phase 2) during which the cost item will be spent.
    - o For all remaining cost items that are included in the total project cost but would not be spent in either Phase 1 or Phase 2 (for example, pre-award costs), select Not applicable.
  - j. Select the **Add this item** button to save the information about the cost item.
  - k. Continue to **+ Add an item** until all costs for implementing the mitigation activity are entered.
4. Add a cost type for management costs:
- a. After adding at least one cost item under the Cost type: Cost estimate, the **+ Add cost type button** will be displayed above the Budget type header. After entering all costs for implementing the mitigation activity, then add a budget item for management costs.
  - b. Select the **+ Add cost type** button.
  - c. Select the only choice available, Management cost. The Cost estimate section will be displayed.
  - d. Select the **Add this cost type** button.



## Tip

Subapplicants must be aware that pre-award costs are undertaken at their own risk; those costs will not be reimbursed if the subapplication is not awarded.



## Tip

Per FEMA policy, a maximum of 5% of the Cost estimate total can be used for subrecipient management costs. If the cumulative amount of subrecipient management cost items exceeds 5%, a warning will be displayed.

- e. Follow the same steps to add the cost items as described in Step 3, except that instead of entering text, choose the **Item** from the drop-down menu. If Other is selected, supply an explanation in a budget narrative.

### 5. Program income

- a. Although uncommon, program income is gross income earned by the subapplicant that is directly generated or earned through implementing the mitigation activity during the period of performance.
- b. This field allows the user to enter known program income that would accrue if the subapplication is awarded.
- c. Be aware that the system will deduct the amount of program income entered from the Grand total and will recalculate the proposed federal share dollar amount and proposed non-federal share dollar amount accordingly.



#### Tip

Refer to 2 CFR 300.307 for an explanation of the grants management requirements for program income.

### 6. Cost Share

After all cost items are entered, supply the amount and sources for the non-federal cost share by following these steps:

- a. **Is this a small impoverished community?**
  - i. To see the definition of a small impoverished community and to review the other information and requirements, read the information provided with the question by scrolling your mouse over the “i” icon.
  - ii. Select Yes or No.

### Small impoverished community and cost share percentages and dollar amounts

- o If Yes is selected, the **% Percentage Proposed federal share** will be set to 90%, and the system will automatically calculate the **% Percentage Proposed non-federal share** to be 10%.
  - o If No is selected, the **% Percentage Proposed federal share** will be set to 75%, and the system will automatically calculate the **% Percentage Proposed non-federal share** to be 25%.
- iii. The system will automatically calculate the **\$ Dollar amount Proposed federal share** and the **\$ Dollar amount Proposed non-federal share** based on the total budget cost that is displayed under the dollar amounts, i.e., the sum of all of the cost items that have been added.
- b. If needed, the user can change the **% Percentage Proposed federal share**, **% Percentage Proposed non-federal share**, **\$ Dollar amount Proposed federal share**, or the **\$ Dollar amount Proposed non-federal share**.
- i. If the value is modified so that the **% Percentage Proposed federal share** is greater than the allowable percentage (i.e., greater than 90% for a small impoverished community, greater than 75% for other communities, or greater than 75% for FMA subapplications that mitigate repetitive loss or severe repetitive loss properties), a text box will be displayed for the user to provide a justification.
  - ii. The **% Percentage Proposed non-federal share** should be adjusted if the value is changed for an “overmatch” situation, where the percentage of committed non-federal funding exceeds the minimum required percentage. (No text box will be displayed requiring a justification.)
  - iii. If a change to one of the percentage or dollar amount fields is made, the system will recalculate values for all **% Percentage** fields and **\$ Dollar amount** fields.
- c. For BRIC program subapplications, subrecipient management costs are provided as 100% federal funding. Therefore, unless the budget amounts are changed, the management cost amount will be included in the matching amount. To change the budget amounts:
- i. After entering all Cost estimate budget line items, multiply the total budget amount by the final non-federal share percentage (e.g., 25%, 10%) to enter in Step iii below.

- ii. Enter the budget line items for Cost type: Management cost.
- iii. Override the amount in the **\$ Dollar amount Proposed non-federal share** field by entering the total budget amount calculated in Step i above . The system will recalculate the values in the four budget fields and the **% Percentage Proposed federal share** value will exceed 75% or 90%.
- iv. When the comment field is displayed, supply an explanation for why the amount exceeds the allowable federal share.

Tip

An example of a satisfactory explanation for why the amount exceeds the allowable federal share is “The Federal share exceeds 75% with subrecipient management costs added.”

# Cost-Effectiveness

Cost-effectiveness is a requirement placed on federal agencies by the Office of Management and Budget (OMB) through Circular A-94, *Guidelines and Discount Rates for Benefit-Cost Analysis of Federal Programs*. For FEMA’s hazard mitigation grant programs, the term “cost-effectiveness” means the result of completing a benefit-cost analysis (BCA) for a proposed project. Circular A-94 stipulates economic requirements for how to conduct a BCA but leaves the procedural structure for how to complete a BCA up to the individual federal agencies. Circular A-94 stipulates that federal agencies should only fund projects where the expected benefits will be greater than the expected costs.

To comply with this requirement, FEMA created the BCA Tool, which is an Excel®-based tool used for calculating benefits and costs as part of a comprehensive BCA. The BCA Tool calculates a project’s benefit cost ratio (BCR) from user-entered values for costs and benefits. Input requirements differ depending on the type and nature of a mitigation project. For example, a BCA for a flood mitigation project requires information about flood elevations and the type of structure, while a BCA for a safe room project requires information about the wind risk at the project location and the number of occupants who would be protected. For a mitigation project to be considered eligible for funding, the BCR must be greater than 1.00, i.e., the benefits must be greater than the costs. As alternatives to using FEMA’s BCA Tool, there are FEMA-approved alternative methodologies that allow subapplicants to demonstrate cost-effectiveness without completing a full BCA. Subapplicants must attach all BCA-related documentation so that the Applicant and FEMA reviewers can check for completeness and accuracy.

On this screen, the user will show what methodology was used to determine cost-effectiveness and will supply information and documentation that supports both the methodology used and the data used in the calculations. This screen is applicable for project, project scoping, technical assistance, and management subapplications but is not applicable for planning subapplications.

#### Method for determining cost-effectiveness

It is possible to select more than one from the following five options:

- **BCA completed in FEMA’s BCA toolkit**

- a. Select this option if a pre-calculated benefits analysis was used.

The FEMA policy memo for each pre-calculated benefits option is referenced in the “Pre-Calculated Benefits” section of FEMA’s BCA website. (See Information Requirements)

### Best Practice

While completing a BCA, BCA analysts should develop a checklist for documentation that must be supplied with the project subapplication. To hasten the review, the user should compile all the documentation into a single file, in the order it appears in the BCA Tool, and attach the single file from this screen.



### Best Practice

For complex project BCAs, it is often helpful for reviewers to have a narrative description that explains the methodology used for completing the BCA. If a narrative report is developed, attach it as documentation from this screen.



### Best Practice

There is a file size limitation of 1 gigabyte. For extremely large files, make every effort to reduce the file size when possible. This may entail actions such as attaching only select pages of a large document or supplying only the critical maps or drawings.

# Environmental/Historic Preservation (EHP) Review Information

As the awarding agency, it is FEMA's responsibility to determine the EHP resources present within the project impact area and to ensure compliance with the applicable requirements for those resources. FEMA must also determine the extent of impacts to EHP resources and whether adequate efforts will be made to minimize any impacts or adverse effects. The subapplicant must provide a minimum amount of information so that FEMA can perform a thorough review and make a determination about potential impacts. However, to hasten the EHP review process, subapplicants and applicants are encouraged to provide *more* than the minimum required EHP-related information. For this reason, many fields in the EHP subsections are indicated as being "optional." While supplying responses to these fields is optional, it is the best way to ensure that FEMA is able to conduct an expedited EHP review of the proposed project subapplication. An example of optional EHP information is a consultation letter from the state or federal agency that oversees a specific review. If a response from an agency has not been received by the application deadline, the user could at least attach the letter sent to the reviewing agency as documentation that the process has been started. Since it takes time to prepare and send consultation letters to agencies and to receive a response, subapplicants should plan ahead and not wait until right before the application deadline to initiate the process.

The EHP Review Information screen includes subsections A–K, where each subsection is used to indicate whether specific EHP law(s) and/or executive order(s) are applicable to the proposed project. In response to each question asked:

- If a Yes response is selected, a checklist of required items will be displayed for users to address and/or attach supporting documentation. The system requires that each box for the required items be checked. If they are not all checked, an error message will be displayed.
- If a No response is selected, the user is essentially stating that there is no presence of resources and no known impacts, and the user may proceed to the next section.
- If a Not known response is selected, the user must provide an explanation or more information.

Each EHP subsection has an optional field to allow users to supply more information if they believe it will assist FEMA in its review. Even if responses of Not known or No are provided, FEMA will still conduct a review, and any disagreement will result either in FEMA requesting additional information or in the subapplication not being selected for funding.

The information requirements and steps to complete subsections A–K of the EHP Information Review screen are listed in the following Sections A–K.

# A. National Historic Preservation Act – Historic Buildings and Structures

The National Historic Preservation Act directs federal agencies to consider the effect of any undertaking on historic properties. This Act led to the creation of the National Register of Historic Places, which is a listing of cultural resources of national, regional, state, and local significance. Any historic buildings or structures that may be affected by a mitigation project must be named in the subapplication.

# Location

The Location section is applicable for project subapplications only. Supplying information about the location of the project is required by regulation. Project location information gives the applicant and FEMA reviewers the ability to understand the context of the project in relation to the geographic area and general surroundings. Also, FEMA keeps an inventory of the location of every project and structure that has been mitigated or is being mitigated under every HMA grant program. On this screen, the user will supply precise location information for the proposed mitigation project and also will provide the location of elements to be mitigated by the project such as buildings and infrastructure. The user will also describe the broader areas that would benefit from and that would be impacted from implementing the project. If a project will mitigate multiple buildings, infrastructure, or utilities, etc., then the user must provide information about each of those inventory types in a “project site inventory” that comprises the address, structural attributes, proposed mitigation action(s), hazard type(s) to be mitigated, owner information, insurance information, and cost-effectiveness information.

The information requirements and steps to complete the sections within the Location screen for the project location, project benefitting area, project impact area, and project site inventory are listed in the following Sections A, B, C, and D, respectively.



## A. Project location

The “project location” refers to the specific location of the project, including the latitude and longitude geospatial coordinates. Show the project location on some type of map(s).

### Steps

#### 1. Provide a detailed description of the proposed project’s location.

- a. Some location information and documentation already may have been supplied in the **Geographic areas description** field in the Scope of work section of the subapplication, which might address a broad area. Do not supply the same location information here. For this detailed description, supply more precise location information and include documentation that relates to the proposed project. The project location information should provide the context for the project, such as a county or community map with the project location highlighted, as well as a more detailed map that shows the project location with greater precision.
- b. Attach maps or other project location information as explained in the **Attachments** field below.
- c. Depending on the location and nature of the proposed project, location information documentation might be street maps, topographic maps, township or quadrangle maps, aerial photographs, or other types of maps on which the project location can be shown. Sources for publicly available map information will differ by hazard type. For example, a Flood Insurance Rate Map is one example of a map that may demonstrate the flood risk for a mitigation project, and it also can be used to show the location of a flood mitigation project. These maps are available at the [FEMA Flood Map Service Center](https://msc.fema.gov/portal/home) (<https://msc.fema.gov/portal/home>).

- d. Other examples of project location information are aerial photographs from an online mapping program (i.e., Google Maps or Google Earth) or from a digital photograph taken by a person or drone.

## 2. Latitude and Longitude

- a. Enter the latitude and longitude for the project location. (Be aware that the latitude and longitude values for individual buildings or infrastructure will need to be entered in the later Project site inventory section.)
- b. Obtain the latitude and longitude through a global positioning system (GPS), online mapping program, geographical information system (GIS), or other system.
- c. Mouse over the “i” for more information about the data entry requirements for these fields. Both values should have six decimal places, and the system will add zeroes to ensure this level of locational accuracy.



### Tip

A latitude value must have two figures before the decimal point and six figures after the decimal point, and a longitude value must have three figures before the decimal point and six figures after the decimal point. For example, a value for latitude could be 44.405590, and a value for longitude could be -068.923467.

If either value is not entered in these required formats, a pop-up message will ask if the entered values can be converted to the required format.

## B. Project benefitting area

The “project benefitting area” refers to the properties that might reasonably benefit from the proposed project. For example, for a flood drainage improvement project that would reduce flood elevations downstream, the project benefitting area would include the structures that would experience reduced flood depths because of the proposed project. The project benefitting area will likely need to be shown on some type of map(s).

## C. Project impact area

The “project impact area” refers to the potential area that the project would impact, beyond the project location and project benefitting area. For example, for a drainage improvement project, the project impact area would include the extent of upstream and downstream impacts.

## D. Project site inventory

The “project site inventory” refers to the detailed list of all buildings, infrastructure, utilities, and other elements that would be mitigated by the project. If a project will mitigate the hazard risk to these types of properties, the user will need to provide information about each building, infrastructure, etc., to form a complete inventory.

Contact your local floodplain administrator to see if there is an elevation certificate on file. Other sources of help are the local floodplain administrator or the Flood Insurance Rate Map or other floodplain map resource.
