Virtual, Asynchronous Training

Kevin Haight shared that we have approximately \$15,000 available for virtual training and the IPSCC approved the contract with Moetivations to provide the training for ECO's. Kevin Haight, Stephanie Harris and Cindy Felton had a tele-conference meeting with Moetivations and discussed the following:

- The training period will be between November 1, 2020 December 15, 2020.
- The training will be free to all ECO's.
- ECO's will receive certificates of completion for each class they complete.
- The training is not POST approved; however, the training can still be applied to the required continuing education for each ECO.
- Moetivations will handle all the registrations.
- Each training class will include a test and survey.
- Moetivations will be sending Cindy Felton the necessary information so she can create a flyer.

Kevin Haight said the Department of Homeland Security Cybersecurity & Infrastructure Security Agency (CISA) will be hosting the following cybersecurity training:

- The training is geared toward the 911 communications center employees.
- It will be a one hour class.
- The classes will be free.
- The classes will be available on October 27, 2020 and November 6, 2020.
- The training is not POST approved; however, the training can still be applied to the required continuing education for each ECO.
- Once the flyer has been finalized Kevin Haight will be distributing it.
