Old Business:

- Review and approve meeting minutes from August 2022 meeting.
 - $\circ\quad \mbox{Did not have a quorum present, so no items were voted on. Any questions on the notes?}$
 - Hearing none, Adam Gonzales motions to accept the meeting minutes. Don Peck seconds the motion.
 - \circ Voting members vote to accept/approve meeting minutes.
- IPSCC Meeting Review of October 2022
 - We got to hear from our new 9-1-1 Coordinator, Beth English, who will be officially starting Nov 1st.
 - o Voted on providing her with training from outgoing Coordinator Craig Logan.
 - Provided notes/minutes from NASNA meeting (refer to minutes in attachments in the calendar invite).

- Brian Shields added the commission meeting, if you want to know specifics of what was
 rearranged in broadband and radio, that committee was merged into a technology meeting.
 A committee named EAS was renamed to the Alerts and Warnings Committee.
- Reviewing previously held NASNA meetings (likely pre-COVID), under <u>NASNA goal 2</u> (legislative rewrite of Title 31), that working group made recommendation to make a small increase 9-1-1 fee. If you want specific documentation, message **Stephanie Johnson**.
- Additional recommendation was for verbiage that more clearly allowed for consolidation of municipalities and counties. The way Title 31 is currently written, it has been a barrier for those wanting to consolidate.
 - Question: What was the recommendation for increase in the 9-1-1 fee? A: "I believe the recommendation was an increase from \$1.00 to \$2.00 on the surcharge."
- NASNA Goal 3: include public safety needs in broadband funding requests: Statewide broadband committee initiative that does not include a formal seat for Public Safety. Stephanie was able to speak with the commissioner after the workgroup was held in September about this concern, and he was aware of the issue but felt confident Public Safety is being considered.
- NASNA Goal 4: develop a statewide addressing standard. The goal is to update existing addresses to match the standard (defined by the NENA I3 for NextGen GIS standards).
- Brian Shields added that the chairman was there and was exposed to a lot of information that he
 wasn't aware of, which was a big positive. These items need to be included in the objectives and
 strategic planning for the commission and included in the next revision of the State
 Communications Interoperability Plan.
- Review of IPSCC Committee Assignments
 - o A list was attached to the calendar invite to access.
- GIS Project Update
 - Adam Gonzales: One of the struggles experienced is trying to onboard the project with DataMark (Payette, Washington, Adams, Valley, and Owyhee counties). Wilma and her team have offered to help with the project to data ready for the validation process. There are additional counties to onboard and make sure their data is up to standard.
 - Wilma is working a lot in the background to get things moving and to identify who to work with at the state level.

New Business:

- Attached copies of Idaho TICP and FOG which Brian Shields will go over.
 - Brian Shields: The Idaho TICP (Tactical Interoperability Communications Plan) and FOG (Field Operations Guide) were just released in final draft at the end of September from the contractor who had been working on these projects.
 - Have received mixed feedback and wants to get more feedback from the "field" on the documents.
 Please look at your specific portion on systems and frequencies that are interoperable and share them as resources. It would be great to hear from Karl (who has provided feedback on the TICP).
 - o These aren't meant to be shared with folks outside of public safety.
- **Brian continued:** Had a great communications course in Pocatello. Will repeat the class in spring 2023 in the Treasure Valley. Will also duplicate the communications leadership and auxiliary communications courses in locations TBD. There is an information technology service leader course that we are also looking at bringing as well. Dates/locations TBD.

- There is also a Communications Assets Survey and Mapping tool which is an online collaborative website that captures communications resources and assets across the state. I have been plugging that to get people signed up on this.
 - CASM Boot Camp Jan 9-13, likely at new EOC at HP Complex.
- Lastly, there was a new version of the NI-FOG (National Interoperability Field Operations Guide) published. I (Brian) will be receiving 100 hard copies and will hand these out at the DIGB meetings.
- Idaho State Radio Users Group Quarterly Meeting Update for September 2022: Karl Rudorf
 - We are starting to have ISRUG meetings quarterly (instead of yearly) to keep pace with the changes.
 - We did discuss Ada County's new ASR site in Avimor that went live in August. It's been successful and doing great.
 - O Discussed next planned upgrade to the 700 radio network in June of 2023. Part of that is Ada's ongoing project to move the master site (currently at ISP) to data center here at Pine in Meridian. Originally planned to do this in the first quarter of 2023 just before the upgrade but decided to postpone until 2024 to allow other site owners time to upgrade systems so moving the master site won't create significant down time during the cutover.
 - Had a couple of good presentations from Motorola on radio infrastructure updates and new features/capabilities with new system releases as well as radio subscriber updates (new radios coming out, end of support dates for older versions).
 - o ISRUG as a group identity discussion: ISRUG is a collection of site owners that meet to discuss the needs of the network and what's coming, what we can do for it, etc.
 - It's not an official organization, and there was discussion about pursuing making it an official organization and forming by-laws, etc.
 - There is interest, and the next step is Karl reaching out to legal to see what this entails, advantages, disadvantages, etc.

DIGB3 Partner Roundtable Updates

- Ada County:
 - Stephanie Johnson: We are continuing to look closely at rough-order magnitude for NG911 contracting, narrowing down vendors, but nothing decided.
 - Ada County Dispatch is working in partnership with our fire and EMS partners, looking at a station alerting project.
 - o Planning AES encryption and working with partners in the valley on this encryption upgrade. We don't want to break interoperability and are in the early planning phases to engage all stakeholders.

- Canyon County:
 - o **Roxanne Wade**: Dispatch was awarded IPCSS 9-1-1 grant funds and will be using those to upgrade to 65" TVs, the KVM switch for mouse/keyboard, and a more robust computer system.
 - o Also waiting to hear back from Spillman on the interface CAD to CAD between Canyon and Ada.

 - Mike Knittel City of Emmett has unexpectedly started transitioning over to FirstNet. The City started running into severe capacity issues with CradlePoint and cellular service.

 - Unanticipated results were the customer service. The FirstNet team has been incredibly involved and localized in making this transition.
